REGULATIONS OF INTERNET AND LOCAL COMPUTER NETWORK USAGE IN THE DORMITORY

Every resident of the dormitory (hereinafter – the User) of Kaunas University of Technology (hereinafter – KTU) who has a personal computer with a network interface can be connected to the local computer network of dormitory and Internet (hereinafter – the Network). The User connected to the Network agrees with the regulations of Internet and local computer network usage in the dormitory (hereinafter – the Regulations) and undertakes to follow them.

1. Connection to the Network:

1.1. the User must sign a written agreement accepting the Regulations and fill online registration form to be connected to the Network;

1.2. all materials used by the Network administrator to connect the User to the Network become the property of the Network;

1.3. the User will be connected to the Network within ten days after filling online registration form.

2. The User connected to the Network obtains the rights to do the following:

2.1. use the Network resources for the purpose of studies, scientific research and realization of non-commercial projects;

2.2. use all the services provided by the Network as long as the Regulations, KTU computer network regulations for users, Lithuanian Science and Studies Computer Network regulations and the laws of Lithuanian Republic are not violated;

2.3. get the Network administrator's consultations about the Network status;

2.4. inform the Network administrator of occurred Network problems, security breaches, and attempts to disturb normal functioning of the Network.

3. The User connected to the Network undertakes to do the following:

3.1. comply with KTU computer network regulations for users;

3.2. use the parameters for connecting to the Network set by the administrator; it is forbidden to change them;

3.3. not to connect additional network equipment without the Network administrator's knowledge and permission;

3.4. respect other users working in the Network as well as their rights and let them use all the Network possibilities;

3.5. ensure the safety of his or her computer;

3.6. not to allow bystanders to use the Network resources, the User takes full responsibility in case an incident happens;

3.7. not to connect other dormitory residents to the Network.

4. The Network administrator has a write to temporally or permanently disconnect the users, who contravene the Regulations or laws of the Republic of Lithuania, from the Network. A person who has committed a serious violation, shall be considered to be excluded from the dormitory or University. According to the procedure of Lithuanian Republic law, the User shall stand all moral and material damage.

5. Temporally disconnected users will be connected to the Network after they resolve the incident and inform the Network administrator.

6. The Users, whose academic institution is a part of Eduroam network, can use the Eduroam wireless network services in dormitories in which they are provided.
